I write further to your request FOI ID 14030 under the Freedom of Information Act 2000 regarding:-

## **Purchasing**

Your request is set out below:

- <u>Purchase of bed capacity in the private mental health sector:</u>
   We would like to know the following information for the past 5 calendar years (please break this down into 2019, 2020 etc).
  - 1. The total contracted spend on private in-patient mental health beds by your trust.
  - 2. The breakdown of the contracted spend on private in-patient mental health beds by your trust (how much has been spent on CAMHS, older adult, PICU, general adult etc).
  - 3. The total non-contracted/ ad-hoc/ unplanned spend on private in-patient mental health beds by your trust.
  - 4. The breakdown of the non-contracted/ ad-hoc/ unplanned spend on private in-patient mental health beds by your trust.
