Other Partner services (MH or otherwise) which individuals were referred on to (by CJLADS)?

The Trust holds a list of other possible partner agencies that individuals could be referred onto however, in order to break down what partner agencies individuals have been referred to over the last six months would require a manual exercise and review of individual records and would exceed the appropriate time limits, as per the Freedom of Information Act 2000 section 12(1) which does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit.

We have attached a redacted copy of the services directory that is used by CJLADS when considering referrals to partner organisations.

It would be helpful to have a 6-month snapshot of demand, in terms of those going through the Custody / CJLADS process – between 1<sup>st</sup> April to 31<sup>st</sup> October this year.
