Specialist seating

Your request is set out below:

1. Please can you provide the last 3 years spend on specialist seating used for patients i.e. recliners and tilt in space chairs not general staff or waiting type seating, excluding VAT, broken down by year i.e. 2020, 2021 and 2022. There is no preference on if this is fiscal or calendar year.

2. In each of these years please could you highlight the 3 models you purchased/rented the most of by quantity

3. Do you purchase outright or rent/hire your specialist seating for the trust? If there is a mixture, please could you quantify the split per year for the last 3 years

We undertake both.
