## **Request for Information**

I write further to your request FOI ID 50578 under the Freedom of Information Act 2000 regarding: -

Alzheimer's Disease

Your request is set out below:

I would be grateful if you could send the Trust's most recent planning document(s) for the
diagnosis and treatment of <u>Alzheimer's Disease</u> including implementation of lumbar punctures
(CSF) and Blood-based Biomarker testing. Please include planning documents that cover the
entire Trust and specific department plans, such as neurology, psychiatry, care of the elderly,
pathology or memory clinic teams.

Please note the Trust does not offer services specifically and solely for the diagnosis and treatment of Alzheimer's Disease. The Trust Memory Assessment and Diagnosis (MAS) service will assess and diagnose irrespective of underlying cause of memory issues. Attached are the MAS Operational Policy and Standard.

2. How many patients were diagnosed with <u>Alzheimer's Disease</u> (*ICD-10 codes = G30, G30.1, G30.8, G30.9, F00, F00.1, F00.2 or F00.9*) in your Trust in the last 12-month period for which data are available?

3. How many patients were diagnosed with Mild Cognitive Impairment and / or Mild Dementia due to <u>Alzheimer's Disease</u> (*ICD-10 codes = G31.84, G30.1, or MMSE scores = 21 to 24*) in your Trust in the last 12-month period for which data are available?

ICD10 Codes are not routinely recorded within the 'diagnosis' section on our clinical records for community-based patients, this data is only routinely collected in respect of an inpatient stays. Therefore, the requested information is not held centrally and is contained within the individual clinical documentation which cannot be extracted as a stand-alone piece of data, reporting against diagnosis will in most cases provide and incomplete and therefore

inaccurate reflection of the potential prevalence. In order to extract the requested information and collate the results would require a manual exercise to identify and review clinical records and would exceed the appropriate time limits, as per the Freedom of Information Act 2000 section 12(1) which does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit
