The information requested is not routinely collected outside normal record keeping of a personnel record. The requested information is not held centrally and is contained within the individual personnel records and archive systems which cannot be extracted as a standalone piece of data. In order to extract the requested information and collate the results would require a manual exercise to identify and review records and would exceed the appropriate time limits, as per the Freedom of Information Act 2000 section 12(1) which does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit.

11. How did the grant money help your organisation?

The feedback from peers has been that the training they received because of this was invaluable to their role, helped them feel more connected to their role and more confident in their peer identity. From an organisational perspective, it has helped us to ensure that all our peers receive the same level of training, have access to that training and support at the start of their journey in this role and have the same information to share back with their teams to make sure we are using our peer workforce as effectively as possible.
