I write further to your request FOI ID 43108 under the Freedom of Information Act 2000 regarding: -

Meeting Minutes

Your request is set out below:

1. Senior Staff Committee meetings in East Kent from 2020-2022 – these were held weekly on a Thursday.

The Trust have been able to locate the attached minutes of meetings.

The minutes have been redacted as the Trust are not obliged, under section 40 (2) FOIA to provide information that is personal information of another person if releasing would contravene any of the provisions of the Data Protection Act 2018. In this instance we believe that the figures are significantly low enough that identification of those involved could be made, and would therefore contravene the first Data Protection principle, therefore section 40 (2) is engaged. The terms of this exemption in the freedom of information act mean that we do not have to consider whether or not it would be in the public interest for you to have the information.

2. Minutes of the meeting that fell on the 3rd June 2021, we ask that copies of all versions which include the embedded minutes and any minutes that mention Mental Health Act Assessment payment information for Tier 2 doctors on call.

The Trust have been able to locate a copy of a document named Senior Medical Staff Committee 03.06.2021, which is attached.

The minutes have been redacted as the Trust are not obliged, under section 40 (2) FOIA to provide information that is personal information of another person if releasing would contravene any of the provisions of the Data Protection Act 2018.
