## **Request for Information**

I write further to your request FOI ID 40804 under the Freedom of Information Act 2000 regarding: -

**Bed Availability** 

Your request is set out below:

Over the last 12 months, in your trust:

- On how many occasions have leave beds (beds occupied by a patient who is on a period of leave but is still within in-patient care) been occupied by another patient.

For the period 1<sup>st</sup> Nov 22 – 31<sup>st</sup> Oct 23 there were <u>794 bed days</u> when a bed assigned to a patient on leave was also assigned to another patient occupying the same bed.

Please note this figure is the number of bed days and not the number of occasions, for example if the leave patient bed was being occupied for 7 nights this is counted as 7 and not 1.

- On how many occasions have there been no unoccupied inpatient beds available within the trust.
- For the period 1<sup>st</sup> Nov 22 31<sup>st</sup> Oct 23 there have been <u>no days</u> where there has been no available bed at the trust on any given day. There have been days where a ward or service is at full capacity, but there have not been any days where the trust has been at 100% bed occupancy with no bed available.
- If out of area placements have been made for patients under the care of the trust over the last 12 months, please list a) the trusts to which patients were sent and b) for each trust, the number of times patient(s) from your trust were sent there.

For the period  $1^{st}$  Nov  $22 - 31^{st}$  Oct 23 there have been 55 out of area placements. Attached shows the breakdown with the hospital name, but we do not have the trust name for those hospitals.

Due to the low numbers involved in this part of the response to your request I would like to confirm that we are unable to release the information, in full. We are not obliged, under section 40 (2) FOIA to provide information that is personal information of another person if releasing would contravene any of the provisions of the Data Protection Act 2018. In this instance we believe that the figures are significantly low enough that identification of those involved could be made, and would therefore contravene the first Data Protection principle, therefore section 40 (2) is engaged.
