5. How many were referred for psychological assessment before prescribing ECT?

The information requested is not routinely collected outside normal record keeping of a clinical record. The requested information is not held centrally and is contained within the individual clinical records and archive systems which cannot be extracted as a standalone piece of data. In order to extract the requested information and collate the results would require a manual exercise to identify and review clinical records and would exceed the appropriate time limits, as per the Freedom of Information Act 2000 section 12(1) which does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit.

6. How many people received psychology therapy before being prescribed ECT?

The information requested is not routinely collected outside normal record keeping of a clinical record. The requested information is not held centrally and is contained within the individual clinical records and archive systems which cannot be extracted as a standalone piece of data. In order to extract the requested information and collate the results would require a manual exercise to identify and review clinical records and would exceed the appropriate time limits, as per the Freedom of Information Act 2000 section 12(1) which does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit.

7. What measures of clinical outcome were used for patients who received ECT and what were the results?

A post ECT review is held on completion of ECT treatment. In addition to this a SMMSE, MADRS and CGI score are also monitored prior to and after treatment.

8. What measures of adverse effects for patients who received ECT were used, and what were the results?

Recovery monitoring is completed for people who receive treatment, an orientation score is completed, there are standardised questions that are also asked of people prior to discharge from the clinic

9. Which professions did the SOAD consult for patients who did not consent?

This varies dependent on the patient however this can include: consultant psychiatrist/ RC; nurse; occupational therapist and psychologist on treating team.
