## **Request for Information**

I write further to your request FOI ID 39616 under the Freedom of Information Act 2000 regarding:-

**Employment tribunals** 

Your request is set out below:

I am requesting information from the following financial years: 2018/19; 2019/20; 2020/21; 2021/22; 2022/23; and 2023/24 to the present day.

Please disclose the following:

Due to the low numbers involved in the response to your request I would like to confirm that we are unable to release the breakdown of information within the questions. We are not obliged, under section 40 (2) FOIA to provide information that is personal information of another person if releasing would contravene any of the provisions of the Data Protection Act 2018. In this instance we believe that the figures are significantly low enough that identification of those involved could be made, and would therefore contravene the first Data Protection principle, therefore section 40 (2) is engaged. The terms of this exemption in the freedom of information act mean that we do not have to consider whether or not it would be in the public interest for you to have the information

1. How many employment tribunal (ET1) claims have been made against the organisation since 2018/19;
