High Secure Units (HSUs), Medium Secure Units (MSUs), Low Secure Units (LSUs) and Psychiatric Intensive Care Units (PICUs) - specifically where these services fall under adult mental health commissioning.

Your request is set out below:

Please provide the information separately for the financial years 2024/25 and 2025/26 Year to Date (YTD) for the following:

1. Spot Contracts (excluding OOA)

- Total income (in £) on spot-priced adult mental health patients
- Total number of adult mental health bed days commissioned
- Average fee (in £) per bed day

For the specified services, KMPT is commissioned under a block contract, Spot contracts are not applicable.

2. OOA Contracts

- Total income (in £) on out-of-area adult mental health patients
- Total number of adult mental health bed days commissioned
- Average fee (in £) per bed day

For the 3 specified services, KMPT is commissioned under block contract, Out of Area Contract are not applicable.

3. Block Contracts

- Total value (in £) of the block contract obtained for adult mental health services
